The purpose of the Affidavit of Financial Support is to help The University of Mississippi obtain complete and accurate information about the funds available to international applicants who wish to study at the university. Strict government regulations require The University of Mississippi to verify the financial resources of each international applicant prior to issuance of either the Form I-20 or Form DS-2019. Failure to complete and submit this form and the accompanying documents with the application for admission will result in **no visa documents** being issued for the student. Without the proper visa status, a student **cannot** participate in UM exchange programs.

On-campus employment is not guaranteed and should not be seen as a significant means of support while at The University of Mississippi.

Arrangements should be made to have funds available at the time of registration for each semester. Payment of tuition and fees for a student's first semester is due on the day of class registration. A 1.5% monthly service fee is added to the balance due after the payment deadline.
